## Jack Russell Terrier Races

10:00 AM Rain or Shine

- Category 1—Puppies 6-12 months (may be split male/female if entries warrant)
- Category 2—Adults, under 12.5" (may be split male/female if entries warrant)
- Category 3—Adults, 12.5" and over (may be split male/female if entries warrant)
- Category 4—Veterans under 12.5", 6 years of age and older, male & female
- Category 5—Veterans 12.5" and over, 6 years of age and older, male & female

**Rosettes Awarded For 6 Places In All Finals**

**Adult Under & Over CHAMPION & RESERVE CHAMPION Rosettes Also Awarded**

**Pre-Entry Fee of \$20.00** includes two races per entrant, on the flat and over hurdles, including heats and finals where applicable.

- Entries should be postmarked no later than **October 3rd** to be considered pre-entry and payment must accompany entry.
- Post entries will be accepted on race day only to fill a heat and for a post entry fee of **\$28.00**.
- Owners may race more than one terrier but must have one handler for each terrier.
- All terriers must be muzzled when racing.
- Terrier race proceeds to benefit the Jack Russell Rescue of Western NY.
- Parking and entrance to the Race Meet is at the expense of the participant.
- Practice racing session for novice terriers after regular racing.
- Race course length is approximately 150 feet in length with start box (6 dogs per heat).
- Volunteers to catch terriers will be greatly appreciated.

Children ages 12 and under are free.

General Parking is free.

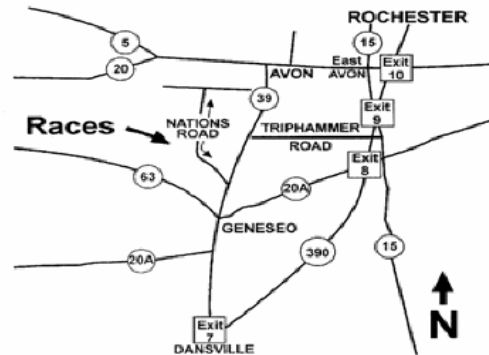
